CONSTRUCTION + HOUSING + MATERIALS

- Building and construction, repair and installation services; building materials; non-metallic rigid pipes for building; asphalt, pitch and bitumen; non-metallic transportable buildings; monuments, not of metal
- Paints, varnishes, lacquers; preservatives against rust and against deterioration of wood; colorants; raw natural resins; metals in foil and powder form for painters, decorators, printers and artists
- Common metals and their alloys; metal building materials; transportable metal building; metal materials for railway tracks; non-electric cables and wires of common metal; ironmongery, small items of metal hardware; pipes and tubes of metal; safes; goods of common metal not included in other classes; ores
- Machines and machine tools; motors and engines; machine coupling and transmission components; agricultural implements (other than hand-operated); incubators
- Apparatuses for lighting, heating, steam generating, cooking, refrigerating, drying, ventilating, water supply
- Wood products
- Household or kitchen utensils and containers; combs and sponges; brushes; articles for cleaning purposes; steelwool; glassware; porcelain
- Furniture, hydro-sanitary equipment, electrical equipment, generators, air conditioners, lightning equipment, accessories, household effects, etc.
- Rubber, gum, asbestos, mica and goods made from these materials; plastics in extruded form for use in manufacture; packing, stopping and insulating materials; flexible pipes, not of metal
- Chemicals used in industry, science and photography, as well as in agriculture, horticulture and forestry; unprocessed artificial resins, unprocessed plastics; manures; fire extinguishing compositions; tempering and soldering preparations; chemical substances for preserving foodstuffs; tanning substances; adhesives used in industry
- Textiles and textile goods, not included in other classes; bed and table covers

TRANSPORTATION

- Auto-show, vehicles; apparatus for locomotion by land, air or water; spare parts
- Transport; packing and storage of goods; travel arrangement
- Tourism, travel agencies

ENERGY

- Power supply and electrical engineering: basic electrical engineering, clean energy, electrical engineering projects, electrical engineering research, electrical engineering solutions, electrical engineering technology, energy conservation, energy management, energy saving, energy sources, green energy, renewable energy

INSTITUTIONS + SOCIAL SERVICES

- Financial institutions and banks, insurance agencies and monetary financing, real estate companies
- Educational institutions, enterprises of the education sector, educational projects, private schools, educational and professional centers
- Entites, municipalities, prefectures, local public administration/institutions, governmental programs, non-governmental organizations, institutional presence, etc.
- Legal services; security services for the protection of property and individuals; personal and social services rendered by others to meet the needs of individuals

BUSINESS + COMMUNICATION + DESIGN

- Publishing houses, topographic equipment, printing machinery, designing studios, etc
- Advertising; business management; business administration; office functions
- Telecommunications
- Scientific and technological services and research and design relating thereto; industrial analysis and research services; design and development of computer hardware and software

FASHION + JEWELLRY + HEALTH

- Clothing, footwear, headgear, cosmetics, detergents, sportswear, shoes, entertainment equipment, gym equipment, etc.
- Precious metals and their alloys and goods in precious metals or coated therewith, not included in other classes; jewellery, precious stones; horological and chronometric instruments
- Pharmaceuticals, medicine, hospital equipment, dental equipment, health institutions, health programs and projects, etc.
- Pharmaceutical and veterinary preparations; sanitary preparations for medical purposes; dietetic substances adapted for medical use
- Leather and imitations of leather, and goods made of these materials not included in other classes; animal skins, hides; trunks and travelling bags; umbrellas, parasols and walking sticks; whips, harness and saddler

FOOD + DRINK

- Meat, fish, poultry and game; meat extracts; preserved, frozen, dried and cooked fruits and vegetables; jellies, jams, compotes; eggs, milk & milk products; edible oils and fats
- Services for providing food and drink; temporary accommodation, hotels
- Food products, alcoholic and non-alcoholic drink, etc.

AGRICULTURE

- Agricultural, horticultural and forestry products and grains; live animals; fresh fruits and vegetables; seeds, natural plants and flowers; foodstuffs for animals, malt, etc.
