

## **Protocol**

**on co-operation in the field of judicial training activities between**

**the Judicial Academy of the Slovak Republic**

**the Judicial Academy of the Czech Republic**

**the Hungarian Academy of Justice**

**the National School of Judiciary and Public Prosecution of the Republic of Poland**

The Slovak Republic as the President of the Visegrad Group in 2018-2019, has organised the Meeting of Directors of Visegrád Four's training institutions with the representatives of the Judicial Academy of the Czech Republic, the Hungarian Academy of Justice, the National School of Judiciary and Public prosecution of the Republic of Poland (hereinafter referred to as the „Participants“).

The Director of the Judicial Academy of the Slovak Republic Mr. Peter Hulla was the Chairman of the 2019 Director's meeting.

The delegations met on 28th and 29th of May 2019 in the Judicial Academy of the Slovak Republic in Pezinok. During the meeting the Participants exchanged information on the current judicial training activities in V4 countries and information on current trends, priorities and new forms of cooperation with emphasis on specialization, efficiency and interactivity.

The participants expressed their interest to reinforce co-operation in the field of judicial training among Visegrad Group countries, and decided to undertake several steps and have agreed as follows:

1. The Participants will exchange information concerning judicial training activities, as well as to exchange good practices and knowledge about the latest development in judiciary;

2. The Participants will co-operate in order to increase the number of joint training activities in foreign languages - legal terminology organized in V4 country and participants will also support exchange visits and conference organizing;
3. The Participants will declare their wish to organise training courses to be opened for judges, prosecutors and court officials of the V4 countries.
4. All the activities shall be organized in accordance with the budget and possibilities of the Participants.
5. Participants will organize in the framework of V4 cooperation training activities as follows:
